Pierce County Fire District 23 Board of Commissioners' Regular Meeting October 14, 2024

The Board of Commissioners for Pierce County Fire District 23 met at 7 p.m., Monday, October 14, 20214 at Station 87. Those present included Chairman Claudia Frey, Commissioners Joe Koehler and Caleb Young, Chief Matt Medford and District Secretary Nancy Adams.

Minutes for the September meeting were unanimously approved as presented. The Secretary gave her report. She noted that her notary stamp was set to expire in April 2025. She asked if the board wanted her to renew it, and they all said she should renew the license. She went over the financial report, noting that the district had \$1,299,400 in investments even after all the vehicle purchases. The chief read his report. The board discussed some of the calls of the previous month.

Under old business, the chief said that since they purchased the new ambulance, it needed a power cot and power load system, because one had never been purchased for Aid 88. After going over various options, the board approved his request for approximately \$71,000 for a new Stryker Power Pro power cot.

Under new business, the board approved Resolution 24-002 for Lewis County Fire District 17 to merge with District 23. While the board had previously approved a similar resolution, it was determined that the dates would need to be changed, and a new paragraph was added that allowed taxation in District 17 in the interim period until the merger was complete.

Ad hoc payments for the month were approved with \$48,818.42 for claims and \$14,572.55 in payroll. The meeting was adjourned at 7:30 p.m.
